

Main points of the campaign to be raised at conferences, events, etc.

Proposal: training on advocacy by the "Good Lobby"

Lluc:

In practical terms FCV has the know-how due to the understanding how important advocacy is and it is in the interest of everybody, especially young people to get trained in advocacy

Organise a seminar to practice Advocacy

Constantinos:

We need to map first the understanding of what advocacy is for young people, through a survey

Huc:

After checking, there is no competence framework for advocacy, non-existent vet.

Necessity of translating the training in the languages of all participating organisations

Boyka:

This can work as a way of involvement and each participating org to undertake the translation for their own target groups

Senad:

We need to address directly those who are responsible at higher levels; Youth organisations suffer directly from the situation and are not in a position to claim for themselves

We need more proof about the necessity of our claim and the subsequent reform.

Lluc:


Collecting evidence of the relevance, outcome and results
